DESCRIPTION OF APPROVED WORK

New construction of a two-family dwelling on 503 Hendee St. This will also require a new curb cut at the side yard of 501 Hendee, a separate lot; I submitted a permit request for a new curb cut in conjunction with this permit. There is an existing servitude at the rear of both lots - continuous across both - that I would like to use as the driveway to access parking. These plans are still incomplete (~5-10% detail remaining) as of 9/13, but I would like to get conceptual approval for the design and intention for parking before finalizing details.
