We hereby propose to furnish the material and perform the labor necessary for the completion of

1. Run new PVC drain lines vent stacks and clean outs throughout where needed and run PVC drain line with a 6" clean out tying into City connection.
2. Remove existing water supply lines and run pex water supply lines with copper outs and brass shut off valves throughout where needed.
3. **Bathroom 1:** Remove existing walk-in bathtub and install [1] shower with [1] shower head.
4. **Bathroom 2:** Remove existing bathtub and install one shower, with [1] shower head.
5. Tie into gas line located on side of house and run new gas line to supply tankless water heater.
6. NP&M will install all plumbing fixtures which include [2] showers, [2] lavs with faucets and trim, [2] water closets, [1] kitchen sink with dishwasher and disposal, [1] tankless water heater and [1] ice maker box for refrigerator.
7. NP&M will install all plumbing fixtures; client will supply all plumbing fixtures.
