
EXIST. FLOOR PLAN

2. ALL WORK MUST COMPLY WITH IRC 2015

3. THIS WORK COMPLIES WITH DESIGN MANUEL AMERICAN WOOD FRAME CONSTRUCTION

- 4. ALL "GLASS OPENINGS" SHALL BE PROVIDE WITH PRECUT MIN 5/8" THICK D.S.B. WITH INSTALL, CLIPS OR SCREWS.
- 5. CONSTRUCTION DESIGN WIND SPEED IS 140 MPH.
- 6. ALL NEW MECHANICAL A/C CONDENSORS, WATER HEATERS SHALL MEET BASE FLOOD ELEVATION
- 7. ALL PLUMBING AND ELECTRIC MUST COMPLY WITH THE LATEST CODE


