## DESCRIPTION OF APPROVED WORK

Renovation of two story electrical double each consisting of two full bathrooms upstairs and a half powder room downstairs. With kitchen and washing machine boxes downstairs and HVAC.

Demo drywall to allow for updating of electrical, plumbing and HVAC systems.

Rough-in plumbing, electrical and HVAC systems to bring up to current code. Install insulation to exterior wall, first floor ceiling and attic. Hang tape, float, texture, prime and paint drywall. Install laminate flooring throughout building. Install door units, base and shoe molding. Set plumbing and electrical fixtures and trim out HVAC.
